

FFWC Car Raffle Official Rules

FFWC car raffle to benefit FFWC building fund campaign is offered only in the United States and is open to legal residents of the US, 18 years of age or older at the time of entry. The raffle begins on March 7, 2010 and ends on September 26, 2010. The raffle is subject to all applicable federal, state, and local laws and regulations, and is void wherever prohibited or restricted by law.

How to enter: To enter the raffle, please register online at www.ffwc.com or you may purchase tickets from a member. Online entries must be received no later than 12:00 PM EST on September 19, 2010. Tickets purchased online may be purchased using Google checkout or other debit/credit card options. Tickets purchased through a member must be completed with name, address, email, and phone number no later than 1:00 PM EST on September 26, 2010. Winner will be drawn on September 26, 2010 at our annual Harvest Fest celebration; you are not required to be present to win. All entries become the sole property of FFWC and will not be returned. A winner's list may be obtained by sending a stamped self-addressed envelope to the following address after November 1, 2010 at: FFWC, Attn: Car Raffle, 1014 Danbury Road, Fayetteville, North Carolina 28311. The winner will be drawn at random by The Honorable Judge Patricia Timmons.

Prizes/Odds of winning: Grand Prize: One (1) new 2010 Nissan Versa Sedan. Approximate retail value \$13,000. Winner must claim prize within 30 days of the official grand prize drawing or a new winner will be selected. Winner must provide valid drivers license before taking vehicle. Winner is solely responsible for tax, tags and any inspections your state may require. If the winner is out-of-state the winner will incur all expenses to transport the vehicle. IRS form 1099 will be issued to the winner for the value of the vehicle. No prize substitution or cash equivalent of the prize will be issued. Second place prize will consist of One (1) \$500 winner. Third place prize consist of One (1) \$250 winner. A minimum of 10,000 tickets will be sold. Odds of winning are determined by the total number of entries received, with the minimum odds of 1:10,000. Each day entries received by internet will be counted.
